Option E confirmed but not everyone is happy

At the Cabinet meeting, St Ives Councillor Julie Kerr, criticised MP Ben Obese-Jecty for the comments he made in Parliament. In particular his assertion that councillors used AI to choose which option to vote for and that NOT voting for option E amounted to treachery.

Prior to HDC's meeting on 19th November, to decide the Local Government Reorganisation (LGR) option that HDC would submit to the Secretary of State, Huntingdon MP, Ben Obese-Jecty, posted online his comments made in Parliament. These included his concern that some HDC councillors were considering voting for option C and might do so because AI suggested they do. He also suggested that any councillor who didn't vote for option E, making Huntingdonshire a Unitary Authority, would be a vote against Huntingdonshire. He also stated that the electorate would remember this at May's elections. He even alluded to them being a 'Traitor' rather than a 'Faithful' and that they would be throwing Huntingdonshire under the Guided Bus.

His lengthy speech included reasons NOT to vote for other options and suggested that councillors, mainly Labour ones, voted out of self interest.

While that may be the case in some areas of the County it doesn't appear true in Huntingdonshire, where the Leader of the Council, Sarah Conboy, a Lib Dem, wanted a free vote and asked councillors to vote for the best option for their constituents.

The following week the Cabinet met to confirm the option HDC would put forward and Councillor Kerr criticised the MP.

She saw his comments as an attempt to undermine HDC's joint administration and to vilify any councillor who might vote for option C and was scathing about his suggestions that an algorithm had led councillors to vote a particular way, when she knew that all HDC councillors had carefully considered the options.

The Riverporter contacted Julie Kerr, Ben Obese-Jecty and Martin Hassall, who was mentioned by the MP, for comment and their responses appear on page 2.

Since our last issue the 7 local councils in Cambridgeshire have sent to the Secretary of State their choices for LGR, which were three choices for option B, two for option D, one for option A and one for option E so it seems that option E may be a long shot.

The Riverporter was delighted to make our Saint very happy. He posted a picture of himself reading the last issue, saying how delighted he was to feature. We are not suggesting St Ivo uses AI, but *The Riverporter* has become **The Riververporter!**

Following the comments made by Councillor Kerr *The Riverporter* contacted MP, Ben Obese-Jecty, to let him know we would be featuring his and Cllr Kerr's remarks in this week's paper. We offered him the opportunity to defend his statements made in Parliament. Below is his reply.

I was shocked and dismayed to see Cllr Kerr use her platform and position at the Council to launch a blistering and vitriolic personal attack against me, rather than use the opportunity to explain why she was voting for Option E, why it is the best choice for Huntingdonshire and the potential dangers of voting for the other options.

Her comments were ill-judged, inaccurate and disappointing, coming from a local councillor I believed I had a good working relationship with.

On the use of AI, Cllr Martin Hassall circulated an email to all councillors, including Cllr Kerr, on 21st June outlining analysis of the options he had collated using Google AI. I have been informed from reliable sources that other councillors have also subsequently used Chat GPT. I have consistently backed Option E ever since it was first announced by Huntingdonshire District Council on 25th September. I have never once sought to take credit for it being on the table. Cllr Kerr should evidence where I supposedly have.

I believe Option E is the best choice, as I clearly laid out during the debate I led in Parliament on 19th November discussing the impact of Local Government Reorganisation on Huntingdonshire. Given the District Council overwhelmingly supported Option E at the vote on the same day and then backed it at Full Cabinet on 24th November local politicians of all persuasions are clearly aligned on this issue. I struggle to see why Cllr Kerr is seeking to create disharmony where there was none.

Following Ben's comments we also contacted Buckden Councillor Martin Hassall to get his reaction, which is below.

I was disappointed by recent comments made in parliament by MP Ben Obese Jecty, which implied that Councillors have been using AI to make decisions. My use of AI has always been strictly for analysis. The document I shared with members was fully referenced and transparent about its use, with the sole aim of providing an evidence based view free from political bias or internal interests.

In June 2025, my analysis showed the South West option (Option C) as the strongest and most resilient future for Huntingdonshire. This conclusion was subsequently supported by officer analysis presented to the Council's committees and Cabinet. By contrast, Option E - promoted by Ben Obese Jecty - would leave Huntingdonshire, on its own, with a population of only 186,000 and an annual recurring loss of £1m. Against government criteria, this makes Option E untenable and increases the likelihood of Option A [being chosen?], partnering Huntingdonshire with Peterborough, which Ben himself has opposed.

To then brand Councillors who voted against Option E as 'traitors' was reprehensible. No Conservative councillor voted against Option E, and it is my view that this language influenced not only his own party colleagues but others as well, discouraging them from opposing an option that is demonstrably flawed. Such rhetoric risks undermining evidence based decision making and unfairly pressures local representatives.

Martin also included with his comments some of the papers that helped him to conclude that Option C was the better choice. Having looked at them it does present a sound case for supporting that option.

Finally we offered Councillor Kerr the opportunity to reply to Ben's letter and we print her comments below.

I am not surprised by his [Ben's] response. To clarify, the MP used his platform and presented information in a way that misrepresented the situation. My comments were simply made in defence of my colleagues. It is disappointing that he chose to use his large platform to publicly discredit opposition members who supported Option C, yet objects when I use mine to challenge his assertions.

No data or business case was available in June 2025; we did not receive that information until the end of October. Anyone who knows how Martin works will understand that he is extremely thorough. I expect he used AI at that early stage only to gain an initial sense of the viability of Option C compared with alternatives being explored by other authorities. With no formal data available at the time, I imagine many people - including Conservative councillors - did the same.

If you listen to Martin's remarks at the full council meeting, it is absolutely clear that he had read all the business cases in detail. He also served on the Joint Overview & Scrutiny Committee that examined LGR, and his contributions clearly reflected a detailed understanding of the papers. I know Martin's work ethic, and the MP's comments about him were a distortion of the facts in my opinion for political gain. My own comments were simply to defend my colleagues and to call out that political game-playing.

So there you have it. A process that should see the reorganisation of local councils to save money, streamline the current system and meet the aspirations of the residents of Cambridgeshire and Peterborough, has concluded with no single agreement between the authorities concerned. In our opinion a totally flawed process that will be decided next summer by the Secretary of State and implemented in April 2028. It has divided opinion and is unlikely to achieve any of the benefits so desperately needed.


This is the reply from County Council Highways: *I have investigated the reported issue, and the defect does not currently meet our criteria for repair. I understand this may be disappointing to learn, however we have set criteria against which we assess defects. These help us prioritise repairs. If the defect gets significantly worse and you believe it meets our criteria outlined, please re-report the defect and we will carry out a further inspection.*

I feel so bad for the poor man who tripped. How many people need to fall over before this is fixed? **Caroline**

Civic Society call for public meeting

The meeting (see right) will examine the implications on St Ives of all the proposed housing & commercial developments outlined in HDCs Local Plan, and publicise objections to the A141 Development Scheme. As the map below shows the Local Plan allows for nearly 24,000 houses in the area and without substantial changes to the infrastructure these proposals risk serious damage to the character and the viability of the area.

The current A141 proposals would be totally inadequate should any of these developments go ahead, putting the viability of the town centre in jeopardy. Last year the Civic Society set up a forum for local groups (FoRSIT) to work together with Town and District Councillors and independent businesses. This is your chance to discuss that future vision for St Ives.
