Dan's the man

Dan Rowe was elected Mayor for 2019/20 at the annual Mayor Making ceremony.

Dan is well-known in the town, having been a councillor since 2016.

The annual ceremony in the Corn Exchange saw Cllr Tim Drye, the outgoing Mayor reporting on his mayoral year and giving awards to those people and groups who have contributed to the life of the town (see pictures).

Tim, without a flat cap in sight, was able to give over £5,000 to local groups as a result of his fundraising efforts. In his speech he said he was immensely proud to have been involved in the centennial celebrations marking the end of the First World War and to be able to present the Freedom of the Town to the Royal Engineers. Having set out his plans, when taking office, to help with the mental health of the town Tim was most proud of the recent movement to make St Ives the first CALM town in the country.

CALM the Campaign Against Living Miserably, will be featuring on national radio on 18 May as part of national mental health awareness week.

Mayor Dan, in his acceptance speech, said that he would also be supporting the work of CALM as well as making every effort to improve the relationship and activities between St Ives and Stadtallendorf, its twin town in Germany. He said that in this age of Brexit where people are getting further apart he wanted to embrace diversity and difference.

Breaking with tradition

Dan also said he was breaking from the tradition of having a personal chaplain and would invite a representative from each of the Town's religious groups to speak before council meetings. Dan nominated his fiancée, Amy Sewell as his Consort.

Councillors then elected Cllr Jonathan Pallant as Deputy Mayor, who nominated his wife, Carrie, as Deputy Consort.

During the ceremony, whilst robing took place, St Ives Poet Laureate, Patrick Macdonald, read out some of his poems including one about being a Mayor and even one about flat caps!



Police Aware?

PCSO Beverley Snell held a Police Surgery in town on Wednesday 1st May. The surgery was held at the bus shelter on Station Road, St Ives, from 1 pm to 3pm and local residents and business owners went along to meet Beverley and discuss any concerns that they may have about policing in our community.

The idea was to give the opportunity to ask questions and let the Police directly know their views. Beverley answered questions from several town residents ranging from lack of police presence, car parking, anti-social behaviour and the recent spate of bag snatching.

Beverley explained that they are doing all they can but confirmed once again the importance of people reporting incidents by calling 101.

In preparing this report *The Riverporter* checked previous records of 101 reports and in 2016 HDC recorded zero reported incidents, so we must assume that when the office of the PCC assesses budgets for following years they assume we don't need police because we don't have trouble.... *The Riverporter* wonders if our readers agree? One interesting report seen in a national newspaper quotes Baroness Newlove who advises... *'Few people know about the 'Community trigger' when victims who have suffered three incidents within six months can seek a review of how agencies have responded to their complaints.'*

Police & Crime Commissioner explains statement?

The Riverporter has received a reply to our email of 12 March to Police & Crime Commissioner Jason Ablewhite. Following his comment at the Town Meeting, when he announced that:

'The fact that the Police and Crime Commissioner is now cheaper to run than the former Police Authority, then you save that money in your pocket or I get that to give to the Chief Constable for more cops.'

We requested to know how he had reached this conclusion when the evidence is that his costs are £225,000 more. The reply we received last Friday is printed in full:

I can confirm that the Police and Crime Commissioner had no intentions of misleading the audience at the St Ives town meeting. His comments were based on the fact that the role of a PCC includes greater responsibility than just setting the strategic objectives for local police forces. The two are not comparable.

Even if you calculate the final year costs of the Police Authority and add inflation, which you have done, the Police Authority did not include the areas of responsibility PCC's such as Victim Support and Community Safety Grants.

Under the terms of the Police Reform and Social Responsibility Act 2011, PCC's must:

- Secure an efficient and effective police for their area;
- Appoint the Chief Constable, hold them to account for running the force, and if necessary dismiss them;
- Set the police and crime objectives for there are through a police and crime plan; [?]
- Set the force budget and determine the precept;
- Contribute to the national and international policing capabilities set out by the Home Secretary; and bring together community safety and criminal justice partners, to make sure local priorities are joined up.

Naturally *The Riverporter* thanked the PCC's office for the reply and pointed out that presumably it was now accepted that there are no savings, either for the Chief Constable to use for additional officers, or for the pockets of tax payers!

Helicopter gave us a fright

Friday May 3rd a huge Police presence in St Ives town sparked alarm at around



1.30pm, when people saw officers in several areas around town near the riverside. The numerous police cars were supported by a helicopter flying low over the river and Harrison Way area. Cambridgeshire

Constabulary however has confirmed that the incident was a false alarm, after a member of the public had called, in good faith, to report that a child was on their own near the river. But after searching the scene it was discovered that the child was in fact safe with an adult. A Cambridgeshire Constabulary spokesperson said: *'We received a call at around 1.30pm to report concern after someone believed they saw an unattended child near to the river in St Ives. We now know the child was with an adult and the incident has ended.'*

Police officers attending The Quay on May 3rd, returned to their car to find it had been vandalised by an opportune passing cyclist. According to witnesses the cyclist had loudly expressed a grudge against police and showed his dislike by smashing up the car.

Visible damage included a smashed wing mirror, tail light and a large dent in the front wing. The cyclist sped off over the town bridge but not before being filmed by the town's new improved street cameras and being caught on a police dash cam. IS NOW THE TIME TO SELL?

For the last three years Brexit has been everywhere, from the minute you got up in the morning until last thing at night, but all of a sudden, it's gone very quiet. Yippee we say, perhaps now we can get on with our lives and that's certainly true for property sales according to figures from Rightmove.

Over the last year, three and four bedroom properties have outperformed other sectors, with prices in this area rising by 0.7% on average year-on-year compared to a national average fall for all properties of 0.1%. Rightmove's data also shows that this sector is more likely to sell than the national average, as well as being more willing to come to the market and we are now seeing more new sellers than this time a year ago.

Everyone has probably been waiting for Brexit to sort itself out before committing themselves to the expense

of a bigger mortgage or the cost of moving, but with no end in sight, buyers are now taking the plunge to move.

The EU's offer of a Brexit extension until October coincides with what is usually the busiest moving season. While it is only a postponement, it is long enough to relieve some of the short-term uncertainty and so it arrives at an opportune time for the housing market.

No doubt there are still a lot of twists and turns to come over the next six months, but this extension could give hesitating home movers encouragement that there is now a window of relative certainty in uncertain times. releases some pent-up demand to take advantage of static property prices and cheap fixed-rate mortgages.
